Product Designation

The Metamere iAC product family consists of high density non-isolated DC-DC power modules intended to be purchased and used as a component in an end-user's power system. The modules currently come in one input voltage range; a wide range 6 – 14.4Vdc input. The output voltage will be between 0.7525V and 5.0V depending upon the model number.

where:

- 1) Shows maximum input range. Some products may offer an optional narrow input voltage range, such as 9.6V to 14V. This option will be differentiated with the ## placeholder.
- 2) Maximum input current will be a data sheet parameter telling the customer the maximum current the power module will draw from 0Vin to Vin,max. The typical current draw will be significantly lower. Fuse value for testing shall be as specified in the product data sheet.
- 3) %%% represents rated nominal output voltage between .7525V (008) and 5V (050). Except for the wide trim version (see below), the output voltage will be adjustable by the customer over a range of +10% to -75% of the rated nominal output voltage. When the output voltage is adjusted up the maximum output power is fixed (i.e. maximum output current is decreased). When the output voltage is adjusted down, the maximum output current may increase (but the available output power will be the same or lower). The 008V option has a wide output voltage adjustment range and can be trimmed up to 5.5
- 4) *** represents rated maximum output current between 1A (001) and 16A (016)
- 5) Total output power is less than or equal to 80W
